4. Cancellations, changes, or corrections must conform to published deadlines. Cancellations must be provided in writing on company letterhead, prior to the closing date for space reservations. There will be no cancellations or changes after space reservation deadline. Advertisers who fail to cancel their order space reservation in writing will be responsible for full payment of the space that was reserved.
5. **Advertising not clearly distinguishable from BDANENY editorial will be labeled as Sponsored Content.**

6. In no case is the Publisher liable for any damages or loss of income that may be caused by the inadvertent omission of an advertisement.
